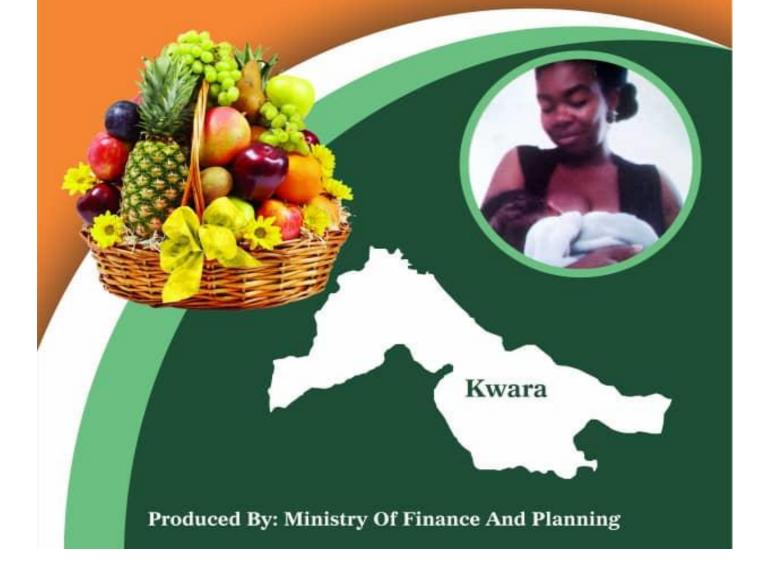

FOREWORD

Malnutrition and nutrition-related issues continue to be of public health concern in Kwara State. It manifests itself mainly as under nutrition, over nutrition and micronutrient deficiencies. Since the beginning of this decade, the close relationship between malnutrition and under-development has continued to be a worry case for discussion ; this case have been so emphasized on, particularly at the various international summits aimed at improving the welfare of women and children. An important conclusion that emerged from these discussions and in particular, from the 2014 International Conference on Nutrition (ICN2), held in Rome, was that nutritional well-being of all people is a pre-condition for development and a key objective of progress in human development. Therefore, reducing malnutrition is an important goal of development, since malnutrition not only slows development; it leads directly to suffering and death.

The recent domestication of the State Policy on Food and Nutrition by the Kwara State Government is another major land mark in the effort of the present administration in addressing the problem of malnutrition, which has been most devastating among young children, pregnant and lactating mothers. The policy has been domesticated to add value and strengthen the synergy among sectors and other initiatives of Government and partners. It is expected that all other policies that have any bearing on food and nutrition should be updated in line with this policy. As a follow up to this, robust intervention programme and cost effective action plan is to be developed to drive the implementation of the policy for effective results.

This in turn will lay a solid foundation for higher productivity and improved physical and mental development among the citizenry.

With the approval of the Policy by the State Executive Council (SEC), I therefore recommend effective implementation of this Policy to achieve the objective of ensuring optimal nutritional status for all Kwara State residents.

EXECUTIVE SUMMARY

The nutrition situation in Kwara State has not improved significantly in the past 10 years and the burden of malnutrition among under-five children remains high. Poverty, inadequate social investment, inadequate dietary intake, poor dietary diversity, poor care practices, frequent infections, diseases, and recently economic hardships are key determinants of malnutrition in Kwara State. The consequences of malnutrition in Nigeria is worrisome including daily loss of about 2,300 under-five children and 145 women of child bearing age, poor physical and mental development, poor productivity and 2-8% reduction in Nigeria's economic growth. Higher mortality and other consequences are inevitable if malnutrition is not squarely addressed in the country and several efforts have been put in place to address this menace.

Taking into consideration the multidisciplinary and multisectoral nature of nutrition, the Kwara State Multisectoral Plan of Action for Food and Nutrition (KWMPAFN) is intended to guide the implementation of nutrition specific and nutrition sensitive interventions and programmes by all Ministries, Departments and Agencies, Development Partners at all levels across the three Senatorial Districts in Kwara State. The goal of the plan is to attain optimal nutritional status for all residents of Kwara State through accelerating the scaling up of priority high impact nutrition specific and nutrition sensitive interventions as well as creating the enabling environment for improved nutrition focusing on the most vulnerable especially women and children as well as internally displaced persons.

The KWMPAFN was developed in line with the National Policy on Food and Nutrition, National Health Strategic Plan of Action for Nutrition and Nigeria Agricultural Sector Plan for Food Security and Nutrition using a multistakeholder participation approach including the relevant MDAs, Development

Partners, the Academia, Civil Society Organizations and the Private Sector. The plan is to run for a period of five years (2021 - 2025). KWMPAFN consists of six result programme areas, eighteen intervention areas and 95 key activities with each of them having an expected outcome and performance indicator(s). The six result programme areas are: achieving food and nutrition security through investment in agriculture; enhancing care-giving capacity; enhancing provision of quality health services; improving capacity to address food and nutrition insecurity problems; raising awareness and understanding of the problem of malnutrition and resource allocation for food and nutrition security at all levels. The National Health Insurance Scheme used the National Data Health Survey NDHS (2018) and MICS (2016) as baseline and targets to reduce hunger and malnutrition by 50%, childhood wasting to 10%, child stunting to 18%, anaemia among pregnant women to 40%, and prevalence of diet-related noncommunicable diseases to 25% while increasing exclusive breastfeeding, intake of appropriate complementary feeding, coverages of vitamin A supplementation, zinc, deworming and access to potable water to 65%, 40%, 90%, 50%, 50% and 80% respectively by 2025.

The costing of the KWMPAFN was done at the activity level over a five-year period taking into consideration all possible costs to implement an intervention or programme. The KWMPAFN prioritize the nutritionally vulnerable groups, particularly pregnant women, lactating mothers and children under 5.

The implementation of the plan of action will involve multi-sectoral actions by the various MDAs across the sectors (Health, Agriculture and Rural Dev., Education, Communications, Tertiary, Science and Technology, Water resources, Finance and Planning, Enterprise, Local Govt., Chieftaincy Affairs and Community Dev., Social Dev. and Bureau of Statistics at multiple levels (State, LGAs and Wards) involving multiple partners (UN Agencies, Bilateral Organizations, Foundations and NGOs) and other stakeholders using existing delivery platforms, community structures and systems, and the Ministry of Finance and Planning (MF&P) is tasked to coordinate the implementation and resource mobilization. The estimated total cost of implementing 18 specific and nutrition-sensitive interventions over 5 years across the country "full coverage scenario" is N4,156,524,503.15; with an average annual public investment cost estimated at N831,304,900.63.

This costed plan could be used as an advocacy tool for improved nutrition financing in Kwara State and incorporates monitoring and evaluation, accountability and learning component for easy tracking of progress and impact evaluation. It will also give Kwara State the leverage to achieve some of the Sustainable Development Goals target by 2030.

CHAPTER ONE

1.0 INTRODUCTION

1.1 State Context Policy Framework

The Kwara State Policy on Food and Nutrition (KSPFAN) provides the framework for addressing the problems of food and nutrition insecurity at all levels in the State. It serves as a guide for the identification, design and implementation of the intervention activities across the various sectors to ensure adequate nutrition and health of Kwara citizens. Malnutrition is the impairment of health due to inadequate or imbalance of one or more nutrients. Malnutrition has multifaceted causes and requires solutions that are multidisciplinary and multisectoral cutting across various sectors including health, agriculture, science and technology, education, trade, economy, and industry. Although many sectors usually develop their sector specific policies, the coordination of programmes and interventions emanating from the implementation of such policies has always been a challenge. The State Policy on Food and Nutrition has placed the responsibility for the coordination of nutrition activities on the Ministry of Finance and Planning (MoF&P) which has the overarching responsibility to coordinate all State policies and programmes across the various sectors. The State Committee on Food and Nutrition (SCFN) resuscitated in 2019 is expected to serve as the platform for the coordination of nutrition programmes and strategies across all sectors.

The idea behind the plan of action in the State was conceived as a result of prevalence of malnutrition across the State. It is hoped that the policy and plan of action will be adequately implemented and thus, bring about needed improvement and interventions in nutrition in the state. This can be accomplished through adequate funding of nutrition programmes and activities, effective coordination and monitoring of the policy in the plan of action.

The National plan of action was developed in 2019 to serve as a guide for the implementation of the National Policy on Food and Nutrition with duration of five years. Despite the policy and the plan of action that emanated from it, nutrition situation in Nigeria continue to deteriorate especially among women and children who are the most vulnerable. This situation is only an indication that the policy and the plan of action were not adequately implemented and thus were unable to bring about the needed improvement in the nutrition situation in Nigeria. Poor funding of nutrition programmes and activities, ineffective coordination and monitoring of the policy and the plan of action were some of the major reasons for this poor performance.

Based on the recognition of the prevalence of malnutrition in the State, non-performance of various interventions and other developments and concerns in the science, practice and programming of food and nutrition, the idea and process of domestication was conceived and started in 2019 and was concluded, printed and unveiled in 2022. The process for the domestication of the plan of action started in 2019 through a multi-stakeholder participation process. The plan of action gives considerations to evidence based nutrition specific and nutrition sensitive interventions and such emerging critical nutrition issues including nutrition in the first one thousand days of life, nutrition during emergencies and the emerging increase in the incidence and prevalence of diet-related Non-Communicable Diseases. The plan of action for State development as espoused in the post 2015 Sustainable Development Goals (SDG) and the Scaling-up Nutrition (SUN) movement and activities.

The urgent need to domesticate high impact and cost-effective nutrition interventions to reduce the worsening nutrition situation in Kwara as demonstrated by Nigeria's signing into the Scaling Up Nutrition (SUN) movement in 2011 further justifies the need for the policy domestication and development of a multi-sectoral plan of action for food and nutrition. The economic recovery and growth plan of Kwara State Government as well as the strong

impetus and commitment to invest in nutrition provide a strong justification for the development of a comprehensive Multi-Sectoral Plan of Action that will form the foundation for human capital development to drive the State Economic Development Plan.

1.2 Food and Nutrition Situation in Kwara

Adequate food and optimal nutritional status are the foundation blocks for the building of healthy, secure lives and thus form the basis for development in any nation. It is well known that the basic cause of the food and nutrition problem is poverty entrenched in the mechanism of governance and institutions which drive the economy. Conceptually, malnutrition in Kwara State arises from poverty, gaps in governance and institutional weaknesses as basic causes whilst food insecurity, inadequate care and access to health services are underlying causes and inadequate food intake and diseases are the immediate causes.

In spite of abundant natural and human resource endowment available in Kwara State, poverty has remained pervasive, multifaceted and chronic. Given the most recent data available, it is estimated that approximately 63% of residents of Kwara live below the poverty line (IJEP2015). Children from the poorest economic guartile have been shown to be four times more likely to be malnourished than children from the richest households [MICS, 2011]. Thus, analysis of the current food and nutrition situation needs to recognise the effects of poverty and make realistic of how the goals and objectives of poverty-reduction projections efforts. including the macro-economic framework, will affect the achievements of this domesticated policy.

The nature and extent of hunger and food insecurity in Kwara State are of public health concern. Available data showed that total average household expenditure on food for the

period between 2009 and 2010 was about 65% (NBS, 2012). Nigeria was ranked 93rd out of 117 on the 2019 Global Hunger Index (GHI report, 2019) whilst another report indicated that the absolute number of food-insecure people was 17 million in 2012, and projected to rise to 43 million by 2022 if the situation is not addressed. The SDG indicators were adopted in 2015 following the MDGs which indicate that at least 12 of the 17 SDGs contain indicators that are highly relevant for nutrition, reflecting nutrition's central role in SDGs. Agriculture provides employment for close to 70% of the Nigerian population.

In Kwara State, agricultural production has remained small-scale at subsistence level and largely dependent on rainfall. Investment in agriculture by Government has not significantly contributed to reduction of under nutrition at the rate needed to meet the Sustainable Development Goals. The economic consequence of this state of food insecurity in terms of productivity loss is huge and requires urgent attention and accounts for almost one-third of the country's Gross Domestic Product.

The food distribution system in Kwara State remains largely inefficient due to factors such as crop seasonality, inadequate storage technology and facilities, inadequate transport and distribution systems, as well as market information. All of these result in considerable spatial and seasonal variation in food production and availability and are responsible for the considerable variations in food prices across the State. The problem is aggravated by lack of adequate storage facilities and basic preservation techniques at the household level. To mitigate this, intervention programmes targeted at the above mentioned challenges should be instituted.

Malnutrition and nutrition-related morbidity continue to be of public health concern in Nigeria and in particular Kwara State. Malnutrition is widespread in the entire State, although the scale and scope varies between the 16 Local Government Areas. Malnutrition manifests mainly as undernutrition, over nutrition and micronutrients (minerals and vitamins) deficiencies generally now referred to as the triple burden of malnutrition.

The trend in undernutrition among children under five has not shown significant changes as revealed by the Nigeria Demographic and Health Surveys (NDHS) 2003, 2008, 2013 and 2018. Stunting rate among under-five in Kwara State was put at 32.5%, wasting at 7.0% and underweight within the same period was 19.9% (NNHS 2018).

The poor state of child nutrition in Kwara State is an indication of inadequate dietary intake, inadequate care of women and children as well as inadequate access to health care and living in an unhealthy environment. That 10.9% of new-borns receive breast milk within one hour of birth, whilst the exclusive breastfeeding rate is 28% (NDHS, 2018).

Indices such as above, position Kwara State among the 12 states experiencing malnutrition in Nigeria. Prevalence of chronic malnutrition among women of childbearing age was put at 7.4% obese, 18.6% overweight (BMI \geq 25.0) and 11.1% are thin (BMI \leq 18.5) (NDHS, 2018). This is an indication of the emerging triple burden of malnutrition in the State. Maternal undernutrition results in low birth weight which, in turn, contributes to high infant mortality and a significant factor in the high incidence of maternal mortality in the State. Infant and under-five mortality in the State are 45/1000 live births (NDHS, 2018).

In recent times, undernutrition has been found to co-exist with overnutrition both at the community and household levels. Public health interventions in Kwara State have focused on issues related to undernutrition and infectious diseases. Whilst the fight against undernutrition has continued, change in lifestyle, diet and economic circumstances have predisposed some of the population towards overnutrition and emerging nutrition challenges. The cause of triple burden of malnutrition is complex with many factors, including nutritional, biological, social, environmental and genetic.

Data on micronutrient deficiency status is limited, and the available summary reports show that <u>29.5% and 13.1%</u> of children and women respectively are Vitamin-A deficient (NFCNS, 2003). Nutritional anaemia prevalence among mothers and children, were <u>24.3 and 27.5%</u> respectively. The high maternal mortality is, in part, attributable to the high incidence of anaemia. The deficiencies of essential micronutrients have been reported to have substantial adverse effects on child survival and development. In particular, Vitamin A and

iodine deficiency have adverse effects on child health and survival, whilst iodine and iron deficiency, together with stunting, have been reported to contribute to children not achieving their full developmental potential (Black et al, 2013).

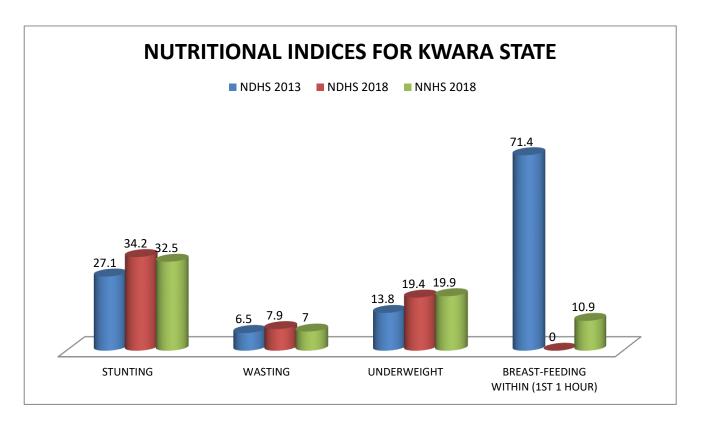

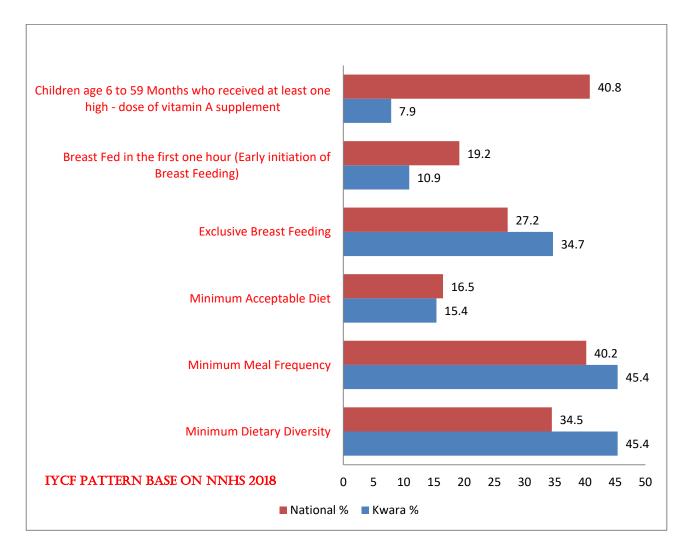

State Nutrition Response

Kwara State has shown commitment to eradicating hunger and malnutrition among her citizens in order to lay a strong foundation for improved standard of living for citizens and socio-economic development of the State. Although the State has invested in some of the key sectors of the economy especially agriculture, health, education, water and sanitation, the impacts of such investments are usually low due to the large population of the State.

The Kwara State Government adopted in 2007 the Maternal Newborn Child Health Week (MNCHW) as a strategy to reduce maternal new-born and child morbidity and mortality in line with MDG targets. MNCHW is a simple one-time delivery mechanism that consolidates services that immediately demonstrates impact in terms of significantly increasing coverage levels of all the core preventive and curative interventions that improve the health of mothers and children. MNCHW is carried out twice every year with the aim of increasing population coverage of needed low cost, high impact interventions and thereby contribute to reduction of morbidity and mortality in mothers, newborns and children less than 5 years of age in the State. However, close to a decade of implementation of these low-cost high impact interventions, there has not been any appreciable improvement in the nutritional status of women and children who are the targets.

1.3 Gaps in Intervention Coverage and Challenges

The coverage of the MNCHW package of interventions has been very low and as such could not make any appreciable impact judging by the large population of the target beneficiaries. Apart from iodized salt consumption, vitamin A supplementation, deworming and focused antenatal care, none of the interventions recorded up to 50% coverage of the target population of beneficiaries.

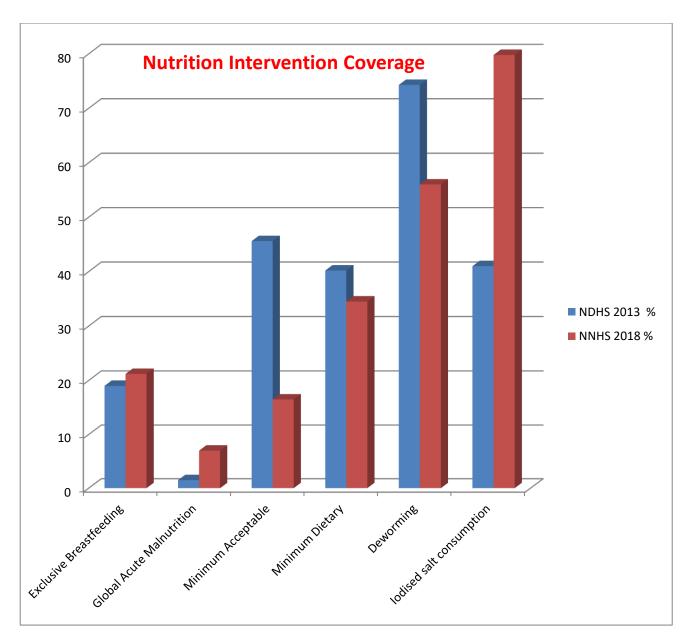

CHAPTER TWO

2.0 FOOD AND NUTRITION ACTION PLAN (2021-2025)

2.1 Background Information

The Kwara State Government is committed to the reduction of hunger and malnutrition in the State. Hence, the State Policy on Food and Nutrition was developed in 2019, in recognition of the multidisciplinary and multisectoral nature of nutrition, the government in collaboration with Development Partners commenced the process for the development of a Multisectoral Strategic Plan of Action using a Multi-Stakeholder Participation Approach. This State Multisectoral Plan of Action for Food and Nutrition (SMPFAN) was developed in line with the National Policy on Food and Nutrition in collaboration with Development Partners, Academia, Civil Society Organizations and Private Sectors. This Plan of Action builds on some sectoral plan of action such as the National Health Strategic Plan of Action for Nutrition (NHSPAN, 2009), Nigeria Agricultural Sector Plan for Food Security and Nutrition. The Plan of Action also covers other sectoral activities such as Education, Water Sanitation and Hygiene, Women Development, Science and Technology, Finance as well as Partnership and Coordination. The plan is to run for a period of five years (2021 - 2025). It is expected that if the plan is implemented effectively by all the sectors, it will address the challenges posed by malnutrition and contribute in promoting optimal nutrition for all Kwara State residents and reduce malnutrition among the vulnerable groups thereby increasing productivity and economic development of the State.

2.2 Rationale

The rationale for the development of the Kwara State Multisectoral Plan of Action for Food and Nutrition (KMPFAN) is to have a document that will serve as a tool to guide the implementation of interventions and programmes by all sectors to address the problems of hunger and malnutrition across the three Senatorial Districts in the State. It evolves from the framework of the strategies outlined in the State Policy on Food and Nutrition and will serve as a working tool to all MDAs and Local Government Areas (LGAs) in their efforts to fight malnutrition and hunger while also serves as a reference material in all current and future interventions to bring about improvement in the nutritional status of Kwara State residents.

2.3 Purpose of Nutrition Action Plan

This SMPFAN will be used by all Ministries, Departments and Agencies (MDAs) across all sectors and Local Government Area (LGAs) to respond to the challenges of nutrition in the State and especially to inform Action Plans that will direct all interventions, programme and activities to be implemented to reduce malnutrition and hunger among the vulnerable and generality of Kwara residents leading to increase productivity and development. If well-funded and implemented, KMPFAN is expected to contribute significantly towards reduction of all forms of malnutrition as a public health problem in the State and as well contribute to the achievement of the Sustainable Development Goals target by 2030.

2.4 Goal, Objectives, Programme Areas and Expected Outcomes

2.4.1 Goal

The goal of the plan is to attain optimal nutritional status for all Kwara State residents through accelerating the scaling up of priority high impact Nutrition Specific and Nutrition Sensitive interventions as well as creating the enabling environment for improved nutrition focusing on the most vulnerable especially Women and Children as well as internally displaced persons.

2.4.2 Objectives

- To achieve the goal of attaining an optimal nutritional status by the year 2025, a number of objectives are articulated as follows:
- ii. To improve food security at the State, LGA, Community, and Household levels.

- iii. To reduce undernutrition in infants, children, adolescents, and women of reproductive age.
- iv. To significantly reduce micronutrient deficiency disorders, especially among the vulnerable.
- v. To ensure incorporation of nutrition education into formal and informal trainings.
- vi. To promote optimum nutrition for people in difficult circumstances, including people living with HIV/AIDS (PLWHA).
- vii. To prevent and control chronic Nutrition-Related Non-Communicable diseases.
- viii. To incorporate food and nutrition considerations into the State and Sectoral Development Plans.
- ix. To strengthen systems for providing early warning information on the food and nutrition situation.
- x. To ensure universal access to Nutrition-Sensitive social protection.
- xi. SMPFAN consist of six result areas and eighteen strategic objectives with each of them having an expected outcome. These result areas and strategic objectives were derived from the policy and aimed at achieving the policy objectives.

2.4.3 Programme Areas

The six result programme areas are the following

2.4.3.1 Food and Nutrition Security

The Strategic Plan of Action will focus on achieving Food and Nutrition Security through investment in agriculture to increase food production, availability, accessibility and affordability to all Kwara State residents. Measures will be taken to improve food harvesting, processing and preservation to reduce postharvest losses, improve food preparation and food quality as well as improve the management of food security crisis and nutrition in emergency situations. It will also include School-Based strategies to reduce malnutrition among school age children and improve their learning, health and nutrition status.

2.4.3.2 Enhancing Care-giving Capacity

Nutrition Specific interventions are a major focus of this Plan of Action and programmes and activities will be implemented to ensure optimal nutrition in the first 1000 days of life. Activities and programme that will address the needs of the socioeconomically disadvantaged are also included.

2.4.3.3 Enhancing Provision of Quality Health Services

Inadequate health care services are underlying cause of malnutrition. The plan will enhance the provision of quality health services through preventing and managing nutrition related diseases to reduce morbidity and mortality associated with malnutrition. Specific interventions to prevent micronutrient deficiencies as well as protect the consumer through improved food quality and safety are also included.

2.4.3.4 Improving Capacity to Address Food and Nutrition Insecurity Problems

Strengthening the enabling environment and building capacity of programme implementers is a priority and activities will be implemented to improve capacity to address food and nutrition insecurity problems as well as provide a conducive macroeconomic environment for improved nutrition status. The needs of the vulnerable groups will be taken care of through implementation of Nutrition Sensitive social protection programmes.

2.4.3.5 Raising Awareness and Understanding of the Problem of Malnutrition

Some of the causes of malnutrition are Socio-Cultural and behavioural in nature and programmes and activities that will promote positive behaviour change and lifestyle through advocacy, communication and social mobilization as well as healthy lifestyles and dietary habits have been included in the plan.

2.4.3.6 Resource Allocation for Food and Nutrition Security at all Levels

Adequate funding and resources for implementation of food and nutrition activities to reduce malnutrition have always been a challenge not only in Kwara State but nationally. This SMPFAN includes aggressive strategies for resource mobilization and investment for nutrition. Activities also included are to ensure budget allocation, timely release and utilization as well as strengthening the coordination capacity of both the institutions and personnel responsible for policy and programme coordination.

2.5 Coordination

The framework for institutional arrangement for the State Policy on Food and Nutrition vested the overall responsibility for the coordination of the Policy and Plan of Action on the State Ministry of Finance and Planning, in order to ensure a Result-Oriented programme implementation and coordination. The State Council on Nutrition under the Chairmanship of the Deputy Governor is the highest decision making body in Kwara State. The State Committee on Food and Nutrition is made up of representatives of relevant MDAs, representatives of relevant Professional bodies, Development Partners and Civil Society Organizations (CSOs), Tertiary Institutions and Research Institutes. All food and nutrition activities will be coordinated at the State and LGA levels by the State Committee on Food and Nutrition (LGCFN)

respectively. It is expected that Ward Committee on Food and Nutrition (WCFN) will also be formed to coordinate the implementation of nutrition activities and programmes at the ward level. The Planning Research and Statistics Department of Local Governments in the State will serve as the secretariat of the Local Government Committees on Food and Nutrition.

2.6 **KMPFAN Strategies**

In order to achieve the set objectives of the Plan of Action, the following strategies will be adopted

- i. Service Delivery
- ii. Capacity Building
- iii. Behaviour Change Communication
- iv. Advocacy and Resource Mobilization
- v. Research Monitoring and Evaluation
- vi. Coordination and Multi-Sectoral Partnership

STATE MULTI-SECTORAL PLAN OF ACTION FOR FOOD AND NUTRITION (SMPFAN) KEY TARGETS BY 2025

- I. Reduce the proportion of people who suffers hunger and malnutrition by 50% by 2025;
- II. Increase exclusive breastfeeding rate from 28% in 2018 to 75% by 2025;
- III. Increase the percentage of children age six months and above who receive appropriate complementary feeding from 10% in 2013 to 40% by 2025;
- IV. Reduce stunting rate among Under-Five children from 32.5% in 2018 to 13% by 2025;
- Reduce childhood wasting including Severe Acute Malnutrition (SAM) from 18% in 2013 to 10% in 2025
- VI. Increase coverage of Zinc supplementation in diarrhoea management from 9% in 2018 to 50% of all children needing treatment by 2025,
- VII. Reduce acute wastage including Severe Acute Malnutrition (SAM) from 7% in 2018 to 2% in 2025;
- VIII. Achieve and sustain universal household access to iodized salt by 2025
- IX. Increase the proportion of children who receive deworming tablets from 19.5% in 2018 to 75% by 2025;
- X. Reduction in anaemia among pregnant women from 67% in 2013 to 40% in 2025;
- XI. Reduce prevalence of diet-related non-communicable diseases by 25% in 2025;
- XII. Increase coverage of Vitamin A supplementation from 7.9% in 2018 to 80% by 2025;
- XIII. Increase by 50% households with relevant nutrition knowledge and practice that improve their nutritional status
- XIV. Increase access to potable water from 49% in 2013 to 70% by 2025;
- XV. Increase the number of relevant MDAs at all levels with functional nutrition unit by 90% in 2025;
- XVI. Reduce the incidence of malnutrition among victims of emergencies by 50% in 2025;
- XVII. Mainstream nutrition objectives into social protection and safety net programmes of all MDAs linked to nutrition by 2025;
- XVIII. Achieve universal access of all school children in the pre- and basic school classes to school-based feeding programmes by 2025; and
- XIX. To arrest the emerging increase in obesity prevalence in adolescents and adults by 2025

CHAPTER THREE

3.0 COSTING

The costing of the KMPFAN was done at the activity level taking into consideration all possible costs (i.e. input cost, transport, personnel, training, supervision, monitoring and evaluation as well as relevant overheads) that will be required to implement an intervention or programme. Thus, the costing matrix contains the costing spreadsheet based on the six result areas, interventions and activities reflecting the following information:

- (1) <u>Annual Activity Cost =</u> unit cost * annual target units
- (2) Total Activity Cost = \sum^{1} (annual cost * annual target units)
- (3)<u>Intervention Total Cost</u> = Σ activity total cost
- (4) Program Total Cost= ∑ total interventions cost
- (5)<u>KWMPAFN Total Cost</u>= ∑ programme total cost

3.1 Basic assumptions

This costing activity required that some assumptions be made about the type and scale of the proposed programmes and interventions. The assumptions about the scope and content of all the interventions were discussed during the three Senatorial Districts consultative meetings as well as the final costing workshop both under the leadership and guidance of the MF&P.

3.2 Costed KMPFAN Timeframe

Although the State Policy on Food and Nutrition has an operational duration which is over a 5-year period, it was agreed among stakeholders that the proposed costing of the KMPAFAN should only be for a five-year (5) period. This is in line with costing done in the National Policy. Moreover, although costing can be made for the seven-year period, any cost projection beyond the 5-year period will be of no use as changing economic environment will

certainly have material effect on the units cost therefore estimating the cost over a fiveyear period (2021-2025) is most appropriate.

3.3 Target groups and intervention by Kwara State.

In line with the Scaling Up Nutrition (SUN) strategy and recognition of the "first 1000 days of the child" as the window of opportunity to have a better impact on the health and development of the child. The Strategic Plan of Action primarily targets pregnant women, lactating mothers and children under 5, particularly those aged 0 to 23 months without necessarily excluding other categories of people affected by the scourge of malnutrition in the State such as school age children, orphans and vulnerable children, adolescents, young adults.

The Strategic Plan of Action proposes the scaling up of nutrition interventions across the State but priority should be given to scaling up interventions (both specific and sensitive) in LGAs where the incidence of stunting exceeds 40% and that of severe stunting 20%, in line with the recommendations of the costing study carried out by the World Bank. It is recommended that full package of nutrition specific and nutrition sensitive interventions be implemented simultaneously in these priority LGAs during the five years of the strategy to maximize impact.

The Strategic Plan of Action is designed to be implemented under six (6) result areas as contained in the State Policy on Food and Nutrition. This operational document shows the intervention logic and activities, unit costs of these activities and budget required for their implementation over the five (5) years period.

3.4 Intervention Approach

The interventions of this Operational Plan are the activities selected to achieve the expected results of the Multisectoral Strategic Plan for Nutrition 2021-2025. These interventions have been identified through multi-stakeholder participatory process which

brings together representatives from MDAs in the State Government, LGAs, CS-SUNN, UN Agency (UNICEF), as well as some implementing organizations and organized private sectors. These interventions were chosen due to their proven efficiency and cost effectiveness and within the specific nutrition context in the State and recommendations of the SUN movement.

The implementation of the plan of action will be led by the various MDAs of government across the State supported by other stakeholders using existing Government's delivery platform (health facilities, schools and community structures and systems). This intervention approach is based on short-term and sustainable development planning to combat chronic malnutrition in the State.

3.5 Efficiency and Effectiveness - Value for Money Approach

The nutrition-specific preventive and curative interventions that make up the intervention packages are highly effective and cost effective according to WHO-CHOICE criteria (WHO 2014). They have all been effective in the State specifically in the LGAs where they have been implemented. The packages are as proposed by The Lancet for the eradication of maternal and infant undernutrition.

These packages include vitamin A supplementation and deworming, complementary and therapeutic feeding, and behaviour change communication (BCC) programmes, which are presented as the most cost-effective interventions in the nutritional costing study of the World Bank in Nigeria (2014) in terms of lives saved, Disability-Adjusted Life Year (DALY) earned and growth delays avoided using the SUN (2010)² costing methods.

Other "nutrition-sensitive" interventions that have been included in the six result areas are also those that have demonstrated positive impacts on nutritional outcomes in Nigeria as well as in other parts of the world and have been found to be the most cost-effective. These

includes: bio-fortification of crops, deworming and promotion of good hygienic behaviour at school, WASH programmes, distribution of fertilizers, e.g. fortified zinc fertilizers to improve agricultural productivity and child growth.

These interventions are multisectoral, but each should be managed and implemented by the responsible sector and Ministries, particularly the Ministries of Health; Agriculture; Education; Water Resources, Women Affairs and Social Development etc.

3.6 Costing Methodology

The costed scaling up plan presents the estimated costs for all six result areas and 18 interventions (both nutrition specific and nutrition sensitive interventions) that represent the modified version of the 10 specific and sensitive intervention programmes advocated by the Lancet series.

The methodology used to calculate the cost of scaling up was to estimate unit costs for all aspects of service delivery (e.g. input costs, transportation and storage, staffing, training, supervision, monitoring and evaluation, relevant overheads, waste, etc.) for each intervention of the actual programs that are currently offered (current coverage) in Nigeria, taking into account the context in which these services are delivered.

This micro-costing method provided opportunity to establish costs by activities and results are presented in the Tables (2-3). At this stage of strategic planning, the future value of costs was not calculated and therefore the effect of inflation is not neutralized on cost estimates. It should be noted that the cost estimate was made in Nigeria National Currency (Naira) and no conversion into USA dollars was made. Furthermore, though the State Policy on Food and Nutrition will be operational through 2025, stakeholders agreed that the costing should be done over a medium period of five years in line with global best practices.

3.7 Total Annual Costs

The main objective of this section is to provide cost estimates for the period of five years (2021 to 2025) in order to allow the government and other stakeholders know the cost required to operationalize the policy and plan of action during the 5-year period. The section also provides the cost estimates to be used for advocacy and resource mobilization from stakeholders (international donors and private sector, civil society and government) in the effort to reduce nutritional disorders in Kwara State.

The Ministry of Finance and Planning (MF&P), is the institution tasked to coordinate the implementation of the KMPAFN by the Kwara State Government. Therefore, the viewpoint and perspective of the costing is institutional, implying that the costs calculated are linked to this institution. Given the multi-disciplinary nature of nutrition, and integration of nutrition in other Sector Strategic Plans, a large proportion of the costs will be met through resource mobilization initiatives of the MF&P in collaboration with the other sectors. For example, the Health sector is already financing some of the health-related nutrition interventions and same applies to the nutrition sensitive agriculture interventions some of which have been costed in the Agriculture Sector Food Security and Nutrition Strategy (ASFNS). Thus, only the most cost-effective nutrition sensitive agriculture interventions are covered in this Multisectoral Plan of Action.

Table 3: Shows the cost of interventions. The estimated total cost of implementing 18 specific and nutrition-sensitive interventions across the State "full coverage scenario" that would require a public investment over the five-year period (2021-2025) is $\mathbb{N4}$,156,524,503.15; with an average annual public investment cost estimated at $\mathbb{N831}$,304,900.63

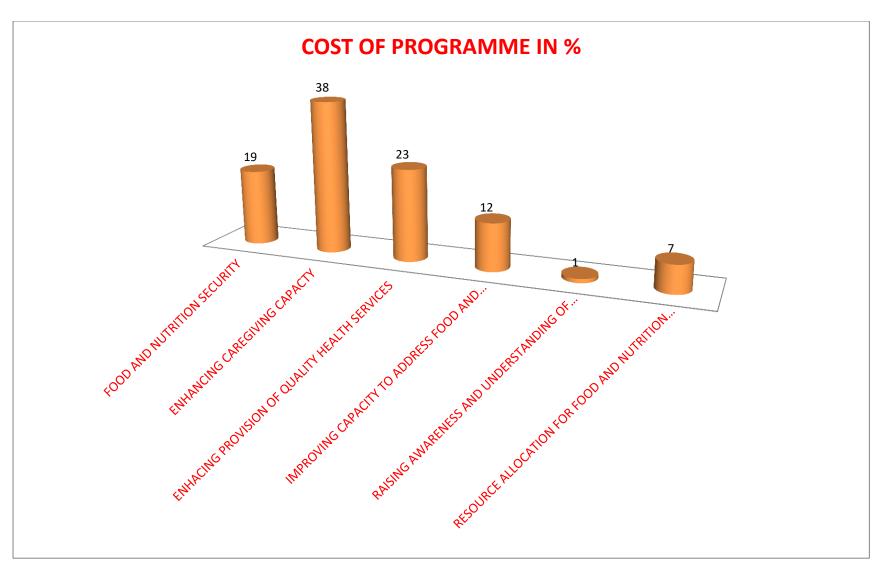

When viewed across the sectors as shown in Fig 4, the health sector which covers two result areas (2 and 3) i.e. enhancing caring capacity and strengthening the provision of quality health services will require respectively 38% and 23% of the total budget over the next five years. This is an indication that the main thrust of the NMPFAN is on prevention rather than cure. The agriculture sector covers result area 1 which is ensuring food and nutrition security at all levels. The total cost of implementing the interventions in this sector amounts to 19% of the total cost of the overall investment required over the five-year period. The low cost of implementing the interventions in this sector amounts in this sector is however due to the fact that most of the interventions that were originally identified have been included in the agriculture sector strategic plan i.e. ASFNS document with appropriate costing. Other reasons included the lack of target population and current coverage figure.

3.8 Financing of the KMPFAN

The cost estimates for the KMPFAN will be used by the Ministry of Finance and Planning to advocate for financial support from government, donor agencies and partners, the private and business sectors, and international and local non-governmental organizations (NGOs). Due to the ever-changing nature of the environment that we live in, where new information on high impact low cost nutrition interventions are continuously emerging, stakeholders must meet regularly to have a consensus on prioritization of interventions and budget allocation for effective utilization of available funds.

Due to budget constraints, the state might not be able to scale up the result areas at the same time and effectively in all LGAs. It is therefore suggested that a scaling scenario based on the burden of stunting, impact, costs and implementation capacity within existing delivery platforms in the state should be considered and support from partners will be embraced to create impact.

3.9 Investment contribution by Ministries, Departments and Agencies

The causes of malnutrition are multifactoral and multifaceted and as such require multisectoral interventions. Several Ministries and Departments of government have critical roles to play in ensuring that malnutrition is reduced in Kwara state especially among children and women who are the most vulnerable. Most nutrition specific interventions in the multisectoral action plan are found in the health sector while nutrition sensitive interventions lies with the other sectors including agriculture, education, information, water resources, science and technology and trade and investment etc.

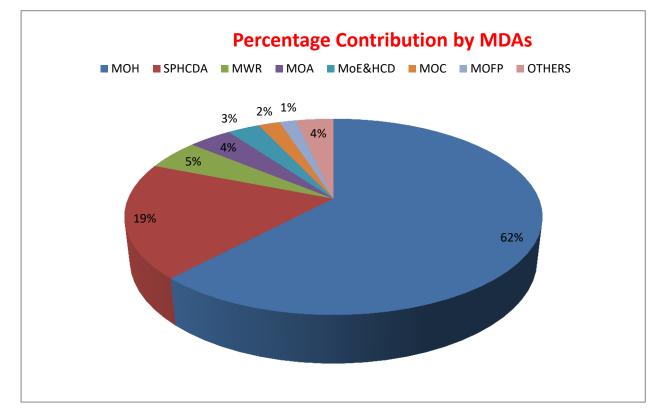

The State Ministry of Health is expected to contribute sixty two percent of the total investment required for nutrition interventions over the five years period followed by SPHCDA with nineteen percent. The State Ministry of Water Resources and State Ministry of Agriculture and Rural Development will contribute 5% and 4% respectively while the State Ministry of Education and Human Capital Development, State Ministry of communication and Ministry of Finance and Planning will contribute 3%, 2%, and 1.5% respectively. The details of the interventions and activities are contained in Annex 4.

CHAPTER FOUR

4.0 MONITORING AND EVALUATION, ACCOUNTABILITY AND LEARNING (MEAL)

Monitoring and evaluation, accountability and learning are part of everyday programme management and are critical to the success of all projects. A MEAL system will allow the tracking of progress, make adjustments and discover any unplanned effects of programmes as well as evaluate the impact the project has made on the lives of the beneficiaries. In addition to this, a MEAL system also helps us to be accountable to our stakeholders through information sharing and developing a complaints or feedback mechanism which can help to guide programme implementation. This State Multisectoral Plan of Action for Food and Nutrition will institute a MEAL system for the purpose of providing accurate, reliable and timely information on the progress of implementation and reporting on how far the strategic objectives are being met, changes in the nutritional status of people in Kwara State especially women and children as well as being accountable to the stakeholders including the donor community. The SMPFAN MEAL system will have the following objectives:

- 1. Collection of accurate, reliable and timely data to monitor the progress of implementation of the plan
- 2. Systematically measure results, incorporate and document experiential learning
- 3. Utilize effective feedback mechanisms to ensure greater accountability to program beneficiaries and key stakeholders
- 4. Facilitate decisions based on evidence and learning that will lead to improvement in programme delivery
- 5. Sharing lessons learned with the stakeholders, development community and policymakers

4.1 Monitoring

KMPFAN implementation progress will be monitored through routine and on-going evaluation of activities in every sector. This will include monitoring using the sectoral routine data collection and reporting system existing in all relevant MDAs as well as community level food and nutrition information and data collection system. There are several nutrition-relevant information systems that collect nutrition-relevant routine data such as Food Security Early Warning System (FEWS), Commodity Price Index, National Health Management Information System (NHMIS), Growth Monitoring, Nutrition Surveillance, Education Information Management System (EIMS) etc. Other Community Level Food and Nutrition Information System including Growth Monitoring and Promotion, Nutrition Surveillance and Food Price Index. This will be complemented with multisectoral annual review of operational achievements and progress, challenges of implementation, lessons learned and recommendations using such State platforms as SCFN meetings, State Nutrition Networking and Nutrition Week.

4.2 Evaluation

Evaluation of SMPFAN will rely on annual joint review meetings to evaluate performance in addition to annual and periodic surveys such as the National Health and Nutrition Survey (NHNS) and others including Multi Indicator Cluster Survey (MICS) and National Demographic and Health Survey (NDHS).

4.3 Baseline data

The annual National Health and Nutrition Survey (NHNS) 2018 and Multi Indicator Cluster Survey (MICS) 2016 have been used to set baseline data. NDHS 2018 and the proposed National Food Consumption and Nutrition Survey will provide further information and data to fill the data gap for baseline.

4.4 Mid-Term Evaluation

For the purpose of mid-term evaluation, MICS 2021-2022 and NHNS 2021-2022 will be used to evaluate progress in the achievement of result. MF&P and Development Partners will collaborate with State Bureau of Statistics to ensure that critical indicators that are required to track the progress of implementation and result are included in the periodic health and nutrition surveys.

4.5 End Term Evaluation

National Demographic and Health Survey (2023) and NHNS (2023) will provide data that will serve the purpose of end of project evaluation.

MF&P management will need to make budgetary provision for establishing collaboration and partnerships with the relevant State and Federal data producing bodies such as the State Bureau of Statistics (SBS), the National Population Commission (NPopC) especially to include in the data tool, some of the important data needed to measure progress of target achievement.

4.6 Accountability

The implementation of KMPFAN will demonstrate accountability to beneficiaries and stakeholders through generation of regular updates and reports on the progress of implementation. MDAs will be required to adopt a reporting template with adjustments on peculiarities based on their mandate. Opportunity to present such updates will use the existing platforms.

4.7 State Committee on Food and Nutrition

MDAs will be required to present and submit quarterly updates on the progress of implementation and result at the quarterly meetings of the State Committee on Food and Nutrition to be called by the Ministry of Finance and Planning. It is expected that a total of four updates will be generated in each year and will form the basis for an annual report.

4.8 National Council on Nutrition

The Secretariat of the National Committee on Food and Nutrition will compile report on a biannual basis to present and submit to the biannual meeting of the National Council on Nutrition to be chaired by the Vice President of the Federation of Nigeria. This report will present information on the level of implementation of interventions and achievement of result across the relevant sectors. The accountability report will also include report on budget allocation, release and utilization. The concern, feedback and complaints of the stakeholders will be used to adjust implementation and influence decisions on programme policies, priorities and actions.

4.9 Learning

KMPFAN will include learning by incorporating lessons learnt, recommendation and observations from accountability mechanism and joint review meetings into programme design.

4.10 The M&E System

The M&E system will be established and domiciled in MOF&P with a robust food and nutrition information collection and management system. The M and E system will have a portal that will be horizontally linked with the M and E unit of the relevant MDAs at the State level as well as vertical link with M and E at the LGA levels. It will provide information on how and to what extent progress is being made towards achieving specified Strategic objectives and targets of the KMPFAN. Data tools and instruments as well as guidelines for data collection and reporting will be developed for both quantitative and qualitative data by MOF&P Monitoring and Evaluation unit in collaboration with other stakeholders especially the donor community and other levels of government. Capacity building at inception and regular on-going training on data tool use, guidelines for data collection and analysis as well as reporting will be carried out for the M and E team and personnel at the State and LGAs levels. Through regular collection of data on activity indicators, output and outcome and M and E report, the progress of implementation of KMPFAN will be monitored and evaluated while scorecards will be developed with lessons learnt.
